NOTES TO PROXY:

- 1. A UNITHOLDER HAS THE RIGHT TO APPOINT AS HIS PROXYHOLDER A PERSON (WHO NEED NOT BE A UNITHOLDER) TO ATTEND AND ACT ON HIS OR HER BEHALF AT THE MEETING OTHER THAN THOSE PERSONS DESIGNATED ABOVE. A unitholder may do so by striking out the names of the persons designated in this form of proxy and inserting the name of such other person on the blank space provided or by completing another proper form of proxy.
- 2. To be voted at the Meeting, this proxy, duly executed, must be delivered in person, by mail or by facsimile, to the REIT's transfer agent and registrar, CST Trust Company, P.O. Box 721, Agincourt, ON M1S 0A1, Fax: (416) 368-2502 (Attn: Proxy Department) prior to 5:00 p.m. (Toronto time) on the second business day preceding the Meeting, being May 5, 2014, or any postponement or adjournment thereof, or with the Chairman of the Meeting on the day of the Meeting or any adjournment or postponement thereof prior to the time of voting. Non-registered unitholders should follow the directions of the intermediaries who are the registered holder of their Units with respect to the procedures to be followed for their proxies. This proxy should be read in conjunction with the notice of annual meeting and the management information circular dated April 2, 2014, as amended by the amendment thereto dated April 22, 2014.
- 3. This form of proxy must be dated and signed by the unitholder or his attorney authorized in writing or, if the unitholder is a corporation, by an officer or attorney thereof duly authorized.
- 4. If this form of proxy is not dated in the space provided above, it shall be deemed to bear the date on which it was mailed to the unitholder.
- 5. If it is desired that the Units represented by this proxy are to be withheld from voting on any ballot that may be called for, with respect to any matters referred to above, the appropriate box or boxes above providing for withholding form voting should be marked with an X or a $\sqrt{}$.
